- 1. Booth spaces measure 10 feet wide and 10 feet deep from the curb into the street. Tents are mandatory; they must be freestanding and cannot be staked into the pavement. Please weight them to withstand wind..**

- 4. 10X10 Booth Space with 110 Watts of Electricity \$40.00**
- 5. 10X20 Booth Space with 110 Watts of Electricity \$45.00**
- 6. Payment is due with application. Payments are non-refundable (regardless of weather) .**
- 7. If a vendor needs electricity, the vendor MUST make a request and fill out the section in**

this application that refers to electrical needs. An additional charge may be added for any electrical needs. You must bring your own outdoor extension cords.

8. Vendor is responsible for cleanup of any trash or debris left in your area before leaving.
